



How this affects your energy bills

An average household would need to spend £826 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could save £346 per year if you complete the suggested steps for improving this property's energy rating.

Estimated energy needed in this property is:

- 9,464 kWh per year for heating
- 3,135 kWh per year for hot water
